3 **Ordinance amending the San Francisco Police Code by amending Sections 1070,**
4 **1070.1, 1070.2, 1070.3, 1070.5, 1070.7, 1070.8, 1070.19, 1070.22, and 1070.24, by adding**
5 **Sections 1017.17.1, 1017.17.2, 1017,17.3, 1070.28, 1070.29, 1070.30, 1070.31, 1070.32,**
6 **and 1070.33, ~~and 1070.34, 1070.35, and 1070.36~~; by repealing Sections 1070.4, 1070.12,**
7 **1070.17, 1070.20, 1070.20-1, 1070.21, and 1070.26; and by adding new Sections 1070.4,**
8 **1070.17, and 1070.20, relating to the application, approval, amendment, suspension,**
9 **revocation, and transfer of Extended-Hours Premises Permits, including changes in**
10 **penalties.**

14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. The San Francisco Police Code is hereby amended by amending Sections
16 1070, 1070.1, 1070.2, and 1070.3, to read as follows:

17 **SEC. 1070. DEFINITIONS.**

18 For the purpose of this Article, unless otherwise provided in this Article, the following
19 words and phrases shall mean and include:

20 (a) "Any Sidewalk Abutting the Premises." The sidewalk not more than 50 feet from the
21 premises of the Business that is located between the premises and a public street. For purposes of this
22 definition, "premises" includes any immediately adjacent area that is owned, leased, or rented by the
23 permit applicant or Permittee.

24 (b) "Bona Fide Nonprofit Club or Organization." Any fraternal, charitable, religious,
25 benevolent, or other nonprofit organization for mutual social, mental, political, or civic welfare, to

1 which admission is limited to members and guests if the revenue accruing therefrom is used exclusively
2 for the benevolent purposes of said organization or agency, and if the organization or agency is exempt
3 from taxation under the Internal Revenue laws of the United States as a bona fide fraternal, charitable,
4 religious, benevolent or nonprofit organization.

5 (c) "Bona Fide Public Eating Place." A place which is regularly and in a bona fide
6 manner used and kept open for the serving of meals to guests for compensation, with and which
7 has suitable kitchen facilities connected therewith, containing conveniences for cooking an
8 assortment of foods which may be required for ordinary meals, the kitchen of which must be kept
9 in a sanitary condition with the proper amount of refrigeration for keeping of food on said
10 premises and must comply with all the regulations of the Department of Public Health. "Meals"
11 means the usual assortment of foods commonly ordered at various hours of the day; the
12 service of such food and victuals only as sandwiches or salads shall not be deemed a
13 compliance with this requirement. "Guests" shall mean persons who, during the hours when
14 meals are regularly served therein, come to a bona fide public eating place for the purpose of
15 obtaining, and actually order and obtain at such time, in good faith, a meal therein. Nothing in
16 this Section, however, shall be construed to require that any food be sold or purchased with
17 any beverage.

18 (d) "Business." The enterprise for which a permit is sought or has been issued under this
19 Article, whether operated on a for-profit or not-for-profit basis.

20 (e) "Conduct that Constitutes a Nuisance." Any conduct that would constitute a violation of
21 the following laws: assault and battery (Cal. Penal Code §240, 242, 245); sexual battery (Cal. Penal
22 Code §243.4); discharging firearm (Cal. Penal Code §246, 246.3); unlawful weapons (Cal. Penal
23 Code §12020; S.F. Police Code §1291); disturbing the peace (Cal. Penal Code § 415, 416, 417);
24 unlawful threats (Cal. Penal Code §422); obstruction of pedestrian or vehicle right of way (Cal. Penal
25 Code § 370); gambling (Cal. Penal Code §§ 330, 337a); rape (Cal. Penal Code §261); statutory

1 rape (Cal. Penal Code §261.5); prostitution and related offenses (Cal. Penal Code §§ 266, 266a,
2 266e, 266h, 266i, 315, 316, 647(b)); sex crimes for which registration is required under the Sex
3 Offender Registration Act (Cal. Penal Code §290); felony sexual assault; loitering for lewd or
4 lascivious purposes (Cal. Penal Code §647(d)); loitering on private property without lawful business
5 (Cal. Penal Code §647(h)); identify theft (Cal. Penal Code §530.5); a violent felony warranting
6 enhancement of a prison term (Cal. Penal Code §667.5); criminal gang activity (Cal. Penal Code
7 §186.22); drug offenses (Cal. Health & Safety Code §§ 11351, 11352, 11359, 11360, 11378, 11379,
8 11378.5, 11379.5); violation of Alcohol Beverage Control laws (Cal. Business & Professions Code §§
9 23300, 25602, 25631, 25657, 25658); public urination or defecation (San Francisco Police Code
10 §153); accumulation of filth (Cal. Health & Safety Code § 17920.3(j)); or excessive noise emissions
11 (San Francisco Police Code Section 49 or Article 29).

12 (f) "Corrective Action." Action which includes, but is not limited to, the following:

13 (1) Requesting assistance from the local law enforcement agency in a timely manner
14 regarding the conduct.

15 (2) Requesting those individuals engaging in Conduct that Constitutes a Nuisance to cease
16 the conduct, or ejecting those Persons from the premises.

17 (3) Revising the Security Plan, subject to approval by the Entertainment Commission or the
18 Director as provided under this Article.

19 (g) "Dance Academy." The term "Extended-Hours Premises" also includes a dance
20 academy wherein students are admitted between 2:00 a.m. and 6:00 a.m., and instruction is given in
21 ballroom or other types of dancing, whether to the students in groups or individually.

22 (h) "Director." The Executive Director of the Entertainment Commission or an individual
23 designated by the Director to act on his or her behalf.

24 (i) "Entertainment." Any of the following, except when conducted in a private residence:
25

1 (1) Any act, play, review, pantomime, scene, song, dance act, song and dance act, or poetry
2 recitation, conducted in or upon any premises to which patrons or members are admitted.

3 (2) The playing or use of any instrument capable of producing or used to produce musical
4 or percussion sounds, including but not limited to, reed, brass, percussion, or string-like instruments,
5 or karaoke, or recorded music presented by a live disc jockey on the premises.

6 (3) A fashion or style show.

7 (4) The act of any female professional entertainer, while visible to any customer, who
8 exposes the breast or employs any device or covering which is intended to simulate the breast, or wears
9 any type of clothing so that the breast may be observed.

10 (j) "Extended-Hours Premises." Every premises to which patrons or members are admitted
11 or which allows patrons or members to remain between 2:00 a.m. and 6:00 a.m. which serves food,
12 beverages, or food and beverages, including but not limited to, alcoholic beverages, for consumption
13 on the premises or wherein Entertainment as defined in Subsection (i) is furnished or occurs upon the
14 premises. The term includes a "Dance Academy."

15 (k) "Manager. The individual authorized by the Permittee to exercise discretionary power
16 to organize, direct, carry out or control the operations of the Business.

17 (l) "Permittee." The person to whom a permit has been issued under this Article.

18 (m) "Person." Any person, individual, firm, partnership, joint venture, association, social
19 club, fraternal organization, joint stock company, corporation, estate, trust, business trust, receiver,
20 syndicate, or any other group or combination acting as a unit excepting the United States of America,
21 the State of California, and any political subdivision of either.

22 (n) "Security Guard." A person who has a valid Proprietary Private Security Officer
23 registration document issued by the California Department of Consumer Affairs; or a person who is a
24 Patrol Special Police Officer appointed by the Police Commission or an assistant to a Patrol Special
25

1 Police Officer and is operating in accordance with rules of the Police Commission governing
2 Patrol Special Police Officers and assistants to Patrol Special Police Officers.

3 (o) "Security Plan." A plan that adequately addresses the safety of persons and property by
4 (i) providing a ratio of one Security Guard to a specific number of individuals as described in
5 the paragraph immediately below at least one Security Guard for every 100 individuals
6 anticipated to be present at any one time during Entertainment events on the premises of the
7 Business, (ii) securing the sidewalk for a 100-foot radius in all directions around the premises of the
8 Business to prevent injury to persons and/or damage to property, and (iii) providing for the orderly
9 dispersal of individuals and traffic from the premises of the Business and within 100 feet of any door
10 that patrons use to enter or exit the premises. The phrase "100 feet" in (iii) of this Subsection (o)
11 means 100 feet from the door in both directions on the same side of the street as the premises of the
12 Business. The plan shall include sufficient staff with the requisite experience to implement the plan.

13 The Security Plan must provide at least one Security Guard for every 100 individuals
14 anticipated to be present at any one time during Entertainment events on the premises of the
15 Business, with the following two qualifications. There must always be at least one Security
16 Guard for every 100 individuals actually present at any one time during Entertainment events
17 on the premises of the Business. Further, in those areas of the City where a conditional use
18 authorization is required for a late night use, on Fridays Thursdays, Fridays, Saturdays, and
19 Sundays from 9:00 p.m. until closing (including early morning hours Saturday Friday,
20 Saturday, Sunday, and Monday) and Saturdays from 9:00 p.m. until closing (including early
21 morning hours Sunday) the Security Plan must provide at least one Security Guard for every
22 100 individuals authorized by the Occupancy Permit during Entertainment events on the
23 premises of the Business.

1 The definition of Security Plan in this subsection 4060(e) 1070(o) does not limit the
2 discretion of the Entertainment Commission and Director as specified in this Article to impose
3 more stringent requirements for a Security Plan as circumstances warrant.

4

(p) "Tax Collector." Tax Collector of the City and County of San Francisco.

5

(g) "Professional Entertainer." A person who is compensated for his or her
6 performance. This definition does not restrict the definition of "Entertainment" in Subsection
7 (i) and is relevant only to the extent the term "professional entertainer" is used in this Article.

8

~~(a) Extended Hours Premises. Every premises to which patrons or members are admitted or~~
9 ~~which allows patrons or members to remain on the premises between the hours of 2:00 a.m. and 6:00~~
10 ~~a.m. which serves food, beverages, or food and beverages, including but not limited to, alcoholic~~
11 ~~beverages, for consumption on the premises or wherein entertainment as defined in Subsections (b) and~~
12 ~~(c) is furnished or occurs upon the premises.~~

~~(1) Dance Academies. An extended hours premises shall also include a dance academy~~
14 ~~wherein students are admitted between the hours of 2:00 a.m. and 6:00 a.m., and instruction is given in~~
15 ~~ballroom or other types of dancing, whether given to the students in groups or individually.~~

16

~~(b) Entertainment. Any act, play, review, pantomime, scene, song, dance act, song and dance~~
17 ~~act, or poetry recitation, conducted or participated in by any professional entertainer in or upon any~~
18 ~~premises to which patrons or members are admitted. "Entertainment" also includes a fashion or style~~
19 ~~show, except when conducted by a bona fide nonprofit club or organization as part of the social~~
20 ~~activities of such club or organization, and when conducted solely as a fund-raising activity for~~
21 ~~charitable purposes. (The term "professional entertainer" as used herein means a person or persons~~
22 ~~who engage in the presentation of entertainment for livelihood or gain.)~~

23

~~"Entertainment," in addition, is defined to mean and include the playing upon or use of any~~
24 ~~instrument that is capable of or can be used to produce musical sounds or percussion sounds, including~~
25 ~~but not limited to, reed, brass, percussion or string like instruments; provided, further, that~~

1 ~~"entertainment" is defined to mean any instrument or device capable of producing or reproducing~~
2 ~~sound, which device is located in a premises open between the hours of 2:00 a.m. and 6:00 a.m.~~

3 ~~(c) Informal Entertainment. Any act, play, review, pantomime, scene, song, dance act, song~~
4 ~~and dance act, or poetry recitation, conducted or participated in by any nonprofessional person or~~
5 ~~persons in or upon any premises to which patrons or members are admitted.~~

6 ~~(d) Person. An individual, firm, partnership, joint venture, association, social club, fraternal~~
7 ~~organization, joint stock company, corporation, estate, trust, business trust, receiver, syndicate, or any~~
8 ~~other group or combination acting as a unit excepting the United States of America, the State of~~
9 ~~California, and any political subdivision of either thereof.~~

10 ~~(e) Operator. Any person operating an extended-hours premises in the City and County of San~~
11 ~~Francisco, including, but not limited to, the owner or proprietor of such premises, lessee, sublessee,~~
12 ~~mortgagee in possession, licensee or any other person operating such place of entertainment or~~
13 ~~amusement.~~

14 ~~(f) Bona Fide Nonprofit Club or Organization. Any fraternal, charitable, religious or~~
15 ~~benevolent, or any other nonprofit organization having a regular membership association primarily for~~
16 ~~mutual social, mental, political and civil welfare, to which admission is limited to members and guests~~
17 ~~and revenue accruing therefrom to be used exclusively for the benevolent purpose of said organization~~
18 ~~and which organization or agency is exempt from taxation under the Internal Revenue laws of the~~
19 ~~United States as a bona fide fraternal, charitable, religious, benevolent or nonprofit organization.~~

20 ~~(g) Admission Charge. Any charge for the right or privilege to enter any extended-hours~~
21 ~~premises including a minimum service charge, a cover charge or a charge made for the use of seats~~
22 ~~and tables, reserved and otherwise.~~

23 ~~(h) Tax Collector. Tax Collector of the City and County of San Francisco.~~

24 ~~(i) "Bona Fide Public Eating Place." A place which is regularly and in bona fide manner used~~
25 ~~and kept open for the serving of meals to guests for compensation and which has suitable kitchen~~

1 ~~facilities connected therewith, containing conveniences for cooking an assortment of foods which may~~
2 ~~be required for ordinary meals, the kitchen of which must be kept in a sanitary condition with the~~

11 **SEC. 1070.1. PERMIT REQUIRED.**

12 (a) It shall be unlawful for any Person to own, conduct, operate, maintain, or to cause or
13 permit to be conducted, operated, or maintained, an Extended-Hours Premises in the City and County
14 of San Francisco without first having obtained a permit from the Entertainment Commission.

15 (b) It shall be unlawful for any Person to own, conduct, operate or maintain, or cause or
16 permit to be conducted, operated, or maintained, an Extended-Hours Premises for which a permit has
17 been granted (1) after the permit has been revoked or is otherwise invalid or (2) for any period of time
18 during which the permit has been suspended.

19 (c) It shall be unlawful for any Person who is required to surrender a permit upon the sale
20 of a Business as required under Section 1070.22 to fail to do so.

21 (d) Any place or premises where an Extended-Hours Premises Permit is sought
22 must conform to all existing health, safety, zoning, and fire ordinances of the City and County
23 of San Francisco, and must have a valid permit to operate (formerly referenced in this Article
24 as a public eating place permit) from the Department of Public Health. The Entertainment
25

1 Commission may issue a permit under this Article conditional upon the applicant receiving the
2 other required permits.

3 ~~*It shall be unlawful for any person to own, conduct, operate, maintain or to participate therein,*~~
4 ~~*or to cause or permit to be conducted, operated or maintained, any extended-hours premises in the City*~~
5 ~~*and County of San Francisco without first having obtained a permit from the Entertainment*~~
6 ~~*Commission.*~~

7 ~~*Any place or premises where a permit to operate is sought must conform to all existing health,*~~
8 ~~*safety, and fire ordinances of the City and County of San Francisco, and must have a valid public*~~
9 ~~*eating place permit from the Department of Public Health.. The Entertainment Commission may issue*~~
10 ~~*a permit under this Section conditional upon the applicant receiving the other required permits.*~~

11 ~~*Any permit granted by the Entertainment Commission conditional upon the applicant receiving*~~
12 ~~*other required permits may be appealed to the Board of Appeals. Such appeal must be filed within 10*~~
13 ~~*days of the final decision of the Entertainment Commission issuing the conditional permit.*~~

14 ~~*Any conditional permit granted by the Entertainment Commission will expire nine months from*~~
15 ~~*the date of the final decision of the Entertainment Commission, if all the other required permits have*~~
16 ~~*not been received.*~~

17 **SEC. 1070.2. FILING APPLICATION, NOTICE TO OTHER CITY DEPARTMENTS,**
18 **AND DEPARTMENTAL REPORTS.**

19 Every person ~~*seeking*~~ ~~*desiring*~~ a permit ~~*or an amendment to a permit under*~~ ~~*pursuant to*~~ this
20 Article shall file an application with the Entertainment Commission upon a form provided by
21 the Entertainment Commission and shall pay a filing fee ~~*as provided by Section 2.26 of this Code.*~~

22 ~~*(b) The Director shall send the application to the San Francisco Police Department, Fire*~~
23 ~~*Department, Department of Building Inspection, Department of Public Health, and Planning*~~
24 ~~*Department. Those departments shall complete all necessary inspections and report their*~~

1 determinations to the Entertainment Commission within 20 City business days of receiving the
2 application.

3 **SEC. 1070.3. APPLICATION FORM.**

4 ~~Operators under any permit issued pursuant to this Article shall be limited to the terms of the~~
5 ~~application.~~ Except as otherwise provided herein, an application for a permit for a Business
6 pursuant to the provisions of this Article shall specify for that Business the same information
7 required under Section 1060.3 of this Code for applications for Place of Entertainment Permits and the
8 applicant shall sign the application under penalty of perjury.

9 ~~(a) The address of the location for which the permit is required, together with the business name~~
10 ~~of such location.~~

11 ~~(b) The name and proposed business address of the applicant. If the applicant is a~~
12 ~~corporation, the name of the corporation shall be set forth exactly as shown in its articles of~~
13 ~~incorporation; and the applicant shall also set forth the date and place of incorporation; the names and~~
14 ~~residence addresses of each of the officers, directors, and each stockholder owning more than 10~~
15 ~~percent of the stock of the corporation. If the applicant is a partnership, the application shall set forth~~
16 ~~the name and residence address of each of the partners, including limited partners. If one or more of~~
17 ~~the partners is a corporation, the provisions of this Section pertaining to a corporate applicant apply.~~

18 ~~(c) Whether or not the applicant or any officer or director or member of applicant, as the case~~
19 ~~may be, has ever been convicted of any crime except misdemeanor traffic violations. In addition to the~~
20 ~~foregoing, any corporate applicant shall state whether or not any stockholder owning more than 10~~
21 ~~percent of the stock of such corporation has ever been convicted of any crime except misdemeanor~~
22 ~~traffic violations. If any person mentioned in this subsection has been so convicted, a statement must be~~
23 ~~made giving the name of the person so convicted, the place and court in which the conviction was had,~~
24 ~~the specific charge under which the conviction was obtained, and the sentence imposed as the result of~~
25 ~~said conviction.~~

1 ~~(d) The names and addresses of the persons who have authority or control over the place for~~
2 ~~which the permit is requested, and brief statement of the nature and extent of such authority and~~
3 ~~control.~~

4 ~~(e) Such information pertinent to the operation of the proposed activity, including information~~
5 ~~as to management, authority, control, financial agreements, and lease arrangements, that is reasonably~~
6 ~~related to the factual determinations this ordinance empowers the Chief to make in reviewing and~~
7 ~~acting upon permit applications as the Chief of Police may require of an applicant in addition to the~~
8 ~~other requirements of this Section. The foregoing examples are in explanation and not in limitation of~~
9 ~~the information which the Entertainment Commission may require.~~

10 ~~(f) A business plan for the proposed extended hours premises, specifying the days and hours of~~
11 ~~operation, the number of patrons, the numbers of employees and their duties, the identity of the~~
12 ~~manager or managers who shall be on premises during all hours of operation, the types or classes of~~
13 ~~entertainment (in terms of the types of instruments, numbers of performers and sound levels) to be~~
14 ~~provided, and the amount of parking, both on-site and off-site, to be provided. If sound amplification is~~
15 ~~to be used, the plan shall also include a specific description of the amplification system.~~

16 ~~(g) The address to which notice, when required, is to be sent or mailed, and the name and~~
17 ~~address of a person authorized to accept service of process, if not otherwise set forth herein.~~

18 ~~(h) Whether the application is for a new permit or for the renewal of an existing permit.~~

19 ~~(i) The Entertainment Commission may require further information as he or she deems~~
20 ~~necessary.~~

21 Section 2. The San Francisco Police Code is hereby amended by repealing Section
22 1070.4.

23 **~~SEC. 1070.4. VERIFICATION OF APPLICATION.~~**

24 ~~Every application for a permit under this Article shall be verified as provided in the California~~
25 ~~Code of Civil Procedure for the verification of pleadings.~~

1 Section 3. The San Francisco Police Code is hereby amended by adding Section
2 1070.4, to read as follows:

3 **SEC. 1070.4. NOTICE REQUIREMENTS AND CONTACT INFORMATION.**

4 (a) Unless otherwise provided in this Article, the following definitions apply.

5 (i) To provide notice "electronically" means to send written notice by email, facsimile or in
6 any other manner that the Director designates as appropriate to transmit written information other
7 than by mail or personal delivery.

8 (ii) To "mail" notice or give notice "by mail" means depositing the notice in a sealed
9 envelope or package, clearly labeled to identify the individual to whom it is sent, in a post office,
10 mailbox, or other facility regularly maintained by the United States Postal Service, by First Class Mail,
11 with postage prepaid. The requirement that notice be mailed within a specified period of time means
12 that the notice is deposited in the mail within that period of time.

13 (iii) "Personally deliver" or "personal delivery" means delivering notice or causing notice to
14 be delivered in person.

15 (iv) "Notice" means notice of a hearing, decision, action required of an applicant for a
16 permit or a Permittee, or any other information that this Article requires to be given or which the
17 Entertainment Commission or the Director find appropriate in implementing the provisions of this
18 Article.

19 (b) Applicants for a permit and Permittees shall provide information necessary to enable
20 the Entertainment Commission and the Director to give notice under this Article. Applicants and
21 Permittees shall provide the Director in writing with a street address where the applicant and
22 Permittee receive mail from the United States Postal Service, and with any email address, facsimile
23 number or other information necessary to enable notice to be sent to the applicant and Permittee
24 electronically. The applicant and Permittee shall keep the information required by this Section current
25 by informing the Director in writing of any change. When the Commission or Director mails or

1 personally delivers notice or sends notice electronically to the applicant or Permittee in accordance
2 with the information most recently provided in writing by that Person, such action shall satisfy the
3 requirements of this Article with respect to how notice is given.

4 (c) In some circumstances, this Article requires notice to the Manager. The Permittee shall
5 provide a telephone and/or cell phone number and a facsimile number or email address for the
6 transmission of notice to the Manager. The Permittee shall keep current the contact information for the
7 Manager and shall notify the Director in writing of any change in this information. The Manager may
8 designate other individuals to whom notice is to be given for any periods of the Manager's absence or
9 unavailability by providing this information in writing to the Director. When the Commission or
10 Director mails or personally delivers notice or sends notice electronically to the Manager, or to any
11 individual designated by the Manager to receive notice in place of the Manager, in accordance with the
12 information most recently provided in writing by the Permittee for the Manager, or by the Manager for
13 his or her designee, such action shall satisfy the requirements of this Article that notice be given to the
14 Manager.

15 (d) The Director may require applicants, Permittees and Managers to provide different or
16 additional contact information for receipt of notice as communication technologies change.

17 (e) A Permittee may change the name and/or address of the individual provided by the
18 Permittee in the permit application to accept service of process by providing written notice to the
19 Director.

20 Section 4. The San Francisco Police Code is hereby amended by amending Section
21 1070.5, to read as follows:

22 **SEC. 1070.5. DETERMINATION OF APPLICATION.**

23 The procedures and standards set forth in Section 1060.5 of this Code shall govern the review
24 and determination of applications for Extended-Hours Premises Permits.

1 ~~(a) When an application is filed for a new permit under this Article, the Entertainment~~
2 ~~Commission shall fix a time and place for a public hearing thereon to determine whether issuance of~~

16 (b)(1) ISSUANCE OF ORDER; RIGHT TO APPEAL TO COMMISSION. On the day that the
17 Director issues an order of limited suspension, the Director shall send the order to the Permittee and
18 Manager by mail or electronically. The order shall state the date that the order issued and the date
19 that it takes effect. To provide the Permittee with an opportunity to file an appeal to the Entertainment
20 Commission, an order of limited suspension shall not take effect for at least five City business days
21 from the date that the Director issues the order.

22 (2) A Permittee may appeal an order of limited suspension to the Entertainment
23 Commission by filing with the Commission Secretary a written request for review within five City
24 business days of the date that the Director has issued the order. The filing of an appeal stays the order

10 securities through an initial public offering which are traded on at least one stock exchange or over-
11 the-counter market.

12 **SEC. 1070.32. APPEALS TO BOARD OF APPEALS.**

13 (a) The following actions taken under this Article may be appealed to the Board of Appeals:
14 The granting or denial of a permit, including a conditionally granted permit, or an amendment to a
15 permit; the suspension or revocation of a permit; and the denial by the Entertainment Commission of
16 an exception from the regulations under Section 1070.19. Any such appeal shall be filed within ten

23 Permittee or permit applicant is not required to exhaust his or her administrative remedies before the

1 Nothing in this Article is intended to restrict or alter in any way the authority vested in the San

10 (a) The Director shall prepare regular quarterly and yearly reports pertaining to

12 March quarter shall be completed no later than April 20; for the April-June quarter, no later
13 than July 20; for the July-September quarter, no later than October 20; for the October-
14 December quarter, no later than January 30. The first quarterly report shall only cover that
15 portion of the quarter that follows the effective date of Ordinance No. _____ . The yearly
16 report shall cover the calendar year and be completed no later than January 30. A One Time
17 Event Permit covering the hours of 2:00 a.m. to 6:00 a.m. on January 1 shall be considered as
18 part of the October-December quarter and as part of the year ending December 31.

19 (b) Quarterly and yearly reports shall be promptly submitted to the Clerk of the
20 Board of Supervisors, the Mayor, the Chief of Police, and any City department that has
21 requested such reports or that in the Director's judgment would have an interest in such
22 reports. These reports shall be promptly posted on the Entertainment Commission website
23 and maintained on the website for at least seven years.

24 (c) Yearly reports shall include, for Extended-Hours Premises Permits, total number
25 of existing permits; number of existing permits in each Police District; name and location of

1 the Premises for each existing permit. Existing permits shall be measured as of December 31
2 immediately prior to submission of the yearly report.

3 (d) Yearly reports shall include, for One Time Event Permits, total number of
4 permits granted during the prior calendar year or granted for events occurring during the prior
5 calendar year; total number of those permits that included authorization for the event to go
6 beyond 2:00 a.m.; number of permits in each Police District; number of permits that included
7 authorization for the event to go beyond 2:00 a.m. in each Police District; name and location
8 of the Premises for each event.

9 (e) Quarterly reports shall include, for Extended-Hours Premises Permits granted
10 during the quarter that is the subject of the report, name and location (street address and
11 Police District) of the Premises; a summary of the Security Plan; a summary of the business
12 plan; and any conditions placed on the permit. In addition, quarterly reports shall include the
13 number of applications for Extended-Hours Premises Permits denied by the Commission,
14 suspended by the Commission or Director, or revoked by the Commission, during the quarter
15 that is the subject of the report, and a summary of the grounds for the denial, suspension, or
16 revocation.

17 (f) Quarterly reports shall include, for One Time Event Permits granted during the
18 quarter that is the subject of the report or granted for events occurring during that quarter,
19 name and location (street address and Police District) of the Premises; whether the permit
20 authorizes the event to go beyond 2:00 a.m.; a summary of the Security Plan; a summary of
21 the business plan; and any conditions placed on the permit. In addition, quarterly reports shall
22 include the number of applications for One-Time Event Permits denied by the Commission,
23 and a summary of the grounds for denial.

24 (g) Quarterly reports shall include a summary of every complaint, whether formal or
25 informal, brought to the attention of the Entertainment Commission or its staff and/or the

1 Police Department pertaining to the operation of an Extended Hours Premises or an event for
